for the International University Cooperation and for Teaching And Scientific Objectives

### CONSIDERING THAT

- that was established in Benevento (Italy), on 2/24/2015, before the Notary Ambrogio Romano - Repertory No. 44270 - Collection No. 18476 - the Foundation called "CUAM University Foundation - University Consortium for Africa and Mediterranean- Registered presso Tax Authorities, dated 24/03/2015 n. 2563 - Series E - CF 92066030625 - headquartered at Via Roberto Ruffilli, snc, Benevento;-----
- that University Consortium already registered in Benevento (Italy) with the Tax Authorities at N. 2565 - Mod. 3 - CF 92053040629, dated 12/04/2011, as C.U.A.M. (University Consortium Africa and the Mediterranean) - headquartered in Via Roberto Ruffilli, snc-, Benevento - Special Scientific Institute, pursuant to Decree No. 623/1996, registered in the National Research, at the Ministry of Education - N. 60745GGJ - Prot. N. 43/62, dated 22/03/2012;-----
- that "CUAM University Foundation" has as Promoter University Scientific the "Second University of Naples", which is the advisory, supervisory and guidance body for all scientific activities, educational and cultural activities carried out by the Foundation;
- that the "CUAM University Foundation" is a non-profit and has as its object to promote and develop the academic cooperation, the higher education and the scientific research in the euro-African Mediterranean.-----

#### **ART. 1 PREAMBLE**

The cooperation shall respect the limits set by this Protocol and the membership does not pose any economic burden on the partner university that, therefore, is not obliged to pay any membership fee or other remuneration for participation in the CUAM, which will support, thus, in full all costs for its functioning and managing.-----

#### **ART. 2 - FREE ACTIVITIES**

Membership in the C.U.A.M. entitles the partner universities, without any economic burden, to the following free activities: **a)** the support for the Erasmus and the other international programs; **b)** the network for partnerships in international projects; **c)** consulting to the publication of articles and books in Italy with the "CUAM University Press Editions Labrys"; **d)** the possibility of propose publications in all the magazines CUAM; **e)** the participation in conferences, lectures, discussions,

which will be held at the headquarters of CUAM; **f)** the participation in the research and the publication of studies and research; **g)** the exchange of information, documentation and scientific publications; **h)** the possibility to appoint a procurator and legal representative of the university partners in Italy; **i)** to facilitate the conclusion of conventions and agreements between the partner universities of CUAM and, between these and Italian and European universities, which are intended for educational and scientific cooperation, recognition of academic titles, the exchange and the mobility of teachers, as well as for the joint production of publications and academic journals); **l)** the possibility of having its own web page on the website of CUAM; **m)** support for information about the academic offerings of the Sun and of the other partner universities; **n)** administrative support for attendance of courses and activities of each study in Italy at the SUN; **o)** the information support to find an accommodation in Italy for students; **p)** the support to facilitate exchanges and mobility of teachers, researchers and students between the partner universities.-----

The C.U.A.M., therefore, will support, in full, all costs relating to these activities.-----

## ART. 3 - PAID ACTIVITIES

The C.U.A.M. facilitate the organization of the courses, the workshops, the master and all formative activity (in medicine, law, justice, business management, etc..) at the headquarters of CUAM or at the individual partner universities and all related costs will be borne by individual participants. The C.U.A.M. provides other services upon request and payment as the possibility of opening a representative office in Italy for the partner universities, to provide university teachers for activities at the headquarters of the university partners and other services as agreed by the parties and to facilitate the conclusion of conventions and agreements between the partner universities of CUAM and, between these and Italian and European universities, which are intended for recognition of academic titles, the exchange and the mobility of teachers;-----

## ARTICLE 4 - TERM

The cooperation protocol will have an unlimited duration, but each participating university will have the right to withdraw at any time by simple communication, which must be notified also by fax or e-mail to the president of CUAM.-----

## ART. 5 - CLOSING CLAUSE

This Protocol, signed by the legal representative of the partner university who subscribes, will be effective from the date of approval and ratification by the President and legal representative of CUAM Professor. Michele Lanna. To resolve any disputes concerning the interpretation and executing of this Convention is applicable the Italian legislation and the parties agree that the court is to Benevento.-----
